All controversies, claims, issues and questions concerning the construction, validity, interpretation and enforceability of the Promotion, the Official Rules, or the rights and obligations of participant and Sponsor in connection therewith, shall be governed by, and construed in accordance with, the laws of the State of New Jersey, without regard to New Jersey or any other conflicts of law principles. IF THE CONTROVERSY, CLAIM, ISSUE OR QUESTION IS NOT RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION BETWEEN THE PARTIES, ANY SUCH CONTROVERSY, CLAIM, ISSUE OR QUESTION SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES,

INC. IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES AND THE CONSUMER MINIMUM STANDARDS OR ANY SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE IN THE STATE OF NEW JERSEY. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS SECTION WILL BE CONDUCTED IN BRIDGEWATER, NEW JERSEY, OR, AT PARTICIPANT'S OPTION, IN THE METROPOLITAN AREA CLOSEST TO THE PARTICIPANT'S RESIDENCE. IN THE EVENT AN PARTICIPANT INITIATES ARBITRATION AGAINST SPONSOR, THE PARTICIPANT SHALL PAY JAMS UP TO \$250 IN ARBITRATION FEES. SPONSOR SHALL PAY ALL OTHER FEES AND COSTS OF JAMS IN CONDUCTING THE ARBITRATION, UNLESS THE ARBITRATOR DETERMINES THAT PARTICIPANT'S CLAIM WAS FRIVOLOUS OR BROUGHT IN BAD FAITH. THE REMEDY FOR ANY CLAIM SHALL NOT INCLUDE THE PAYMENT OF ANY ATTORNEY FEES OR OTHER COSTS IN BRINGING THE PROCEEDING AND NO PARTY SHALL BE ENTITLED TO RESCIND THIS AGREEMENT. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

Sponsor reserves the right in its sole and absolute discretion to cancel, modify and/or suspend this Promotion at any time if fraud, technical failures, including any network server or hardware failure, viruses, bugs, errors in programming, or any other errors or other causes (such as force majeure events) impairs the administration, security, integrity or proper play of the Promotion.
